NOTIFICATION

In pursuance of the common judgment passed by the Hon'ble High Court of Tripura on 21.08.2013 in connection with the WP(C) No. 237 and WP(C) No. 238 of 2013, it has been decided by the Government that the Tripura Board of Joint Entrance Examination will publish a common merit list for the PCM & PCB groups as per the provision of the Tripura Scheduled Tribes and Castes Reservation Act 1991. It has also been decided that the common merit list shall be followed for the purpose of counseling and distribution of available seats meant for Central pool seats as well as State seats for PCM & PCB groups amongst the eligible candidates qualifying in Tripura Joint Entrance Examination-2014.

Accordingly, the Tripura Board of Joint Entrance Examination has published a common merit list both for the PCM & PCB groups separately. The available seats meant for Central Pool seats as well as State seats of PCM & PCB groups amongst the eligible candidates will be distributed based on the common merit list.

This Booklet contains results (arranged in order of merit) of the candidates who appeared in Tripura Joint Entrance Examination-2014.

The pages of this Booklet contain the merit list of candidates who appeared at this Examination in **PCM Group** and **PCB Group** respectively.

The common merit list has been published for each Group in order of Merit as follows:

For **PCM Group : Merit position upto 2993 has been published**

Merit List of PCM Group contains the Merit Positions of all the candidates who appeared in PCM Group along with their enrolment number, category (SC or ST, where applicable) and Quota (EX or PH, where applicable).

For **PCB Group : Merit position upto 3831 has been published**

Merit List of PCB Group contains the Merit Positions of all the candidates who appeared in PCB Group along with their enrolment number, category (SC or ST, where applicable) and Quota (EX or PH, where applicable).

Certain Colleges and Universities stipulate specific percentage of marks in last qualifying Examination (H.S. or equivalent) and some other conditions including cut-off marks, if any, for admission / entry to different streams / subjects of respective Colleges and Universities against seats reserved for Tripura. Accordingly, selection will be made on the basis of Eligibility Criteria and cut-off marks, if any, obtained in Tripura Joint Entrance Examination as specified by the respective departments of State & Central Governments/ Institution/ Council / Body.

Candidates will be issued nomination letters for various courses of study on the basis of their performances in the Tripura Joint Entrance Examination. For issuing of nomination letters a programme will be fixed for counseling and verification of original certificates, in which the candidates will have to present themselves with all **Certificates in ORIGINAL**. The programme (including date, time, venue, etc.) will be published in the leading Dailies / A.I.R. / Electronic Media including our website: www.tbjee.nic.in . Candidates are advised to wait for announcement of this Programme and they should note that no individual call letter will be issued to them for counseling.

The Board will not be responsible for any printing mistake in publication of result by concerned dailies / organization.
