The information below may please be noted:


- (a) Eligible registered candidates who appeared in TBJEE-2020 and got position in the merit list may **attend 2nd round of counselling, except** those who have been allotted any seat earlier through TBJEE counselling will not be considered for selection.
- (b) **For mop-up/Spot round counselling**, all eligible candidates who appeared in the TJEE-2020 and have not allotted any seat from 1st & subsequent round of counselling in connection with TJEE-2020.
- Students got merit position in TJEE 2020, but did not registered in the counselling process for the 1st Round of Counselling, will not be eligible for 2nd round of counselling, unless otherwise granted on special ground.
- The State Govt. reservation policy will be maintained while allotting seats.
- The terms and conditions for admission of students to ICFAI University Kamalghat and Techno College of Engineering Maheshkhola as laid down by them shall be applicable.
- During Mop-up/ Spot round of counselling, all candidates willing to appear in the counselling are required to bring the original certificates along with one set of photocopy of the same and recent photograph of the candidate.
- Allotment of seat is provisional, subject to the verification of original testimonials by the concerned Institutes during admission process.
