Counselling of Tripura Board of Joint Entrance Examination for the academic session 2025-26 for allotment of seats made available to the Board till-date for different Professional Degree Courses will be held through online mode. Online choice filling will be notified later. All eligible and registered candidates, interested in availing seats mentioned below, are directed to go through the seat matrix for PCM group carefully before choice filling to avoid any hurry. No candidate will be considered for allotment of any, seat unless he/she registered and filled up choice for online counselling within the stipulated date.

For the academic session 2025-26, Tripura Board of Joint Entrance Examination (TBJEE) has received the following seats for PCM group (categorically mentioned in Table No. 1) in different Degree Courses for selection of candidates through counselling from the Common Merit List of PCM Group of Tripura Joint Entrance Examination – 2025 as mentioned bellow.

5% seats are reserved for Person with Disability (PWD) candidates as per reservation rules which will be marked after registration of the candidates to follow the horizontal reservation in this regard.

2% seats are reserved for Ward of Ex-Serviceman (WESM) candidates.

In the online counselling process, the Board shall allocate the seat of candidate's choice in order of merit position of common merit list from PCB and PCM groups separately. Counselling of the PCB group precedes to that of the PCM group. The allotment of seats is provisional subject to the verification of the original testimonials in the concerned institute at the time of admission.

1. A candidate who is registered but does not participate in choice-filling within the stipulated time period for first round of counselling (PCB & PCM both) shall not be permitted for participating in the second and subsequent round of counselling unless if he/she seeks permission showing acceptable reasons with necessary documents (Original and Hard copy) within two days after the first round of seat allotment (PCB & PCM both). In these cases the decision of the Board shall be final and these will not be a right on the part of the candidate. 2. It is noted that the selection of candidate for a particular course to a certain college/university will be subject to be fulfillment of the eligibility criteria, if any of the respective college/university/institution, from where seat is sponsored.
3. There will be no wait list of the candidates at the time of counselling. The successive occasions, fresh counselling will be held as per procedure.
4. A candidate who opted seat during first round of counselling but subsequently intended for surrendering the seat shall have to apply to the respective sponsoring department for surrendering the seat within 3 (three) days positively excluding the date of allotment of the seat. However, if an eligible C-group candidate who had filled up his/her choice for both PCB and PCM group and a seat is allotted from PCB group which is not his/her desired seat and is reluctant to accept his choice after allotment. In that case, he/she must surrender the seat within 2 days of the seat allotment excluding the date of allotment of the seat, to be considered for getting an allotment from PCM group.
5. No separate call letter will be issued to any Candidate.
6. Before the choice filling by the candidates but after notification of counselling if any of the seats from the sponsoring departments/institutes/Universities are received by the TBJEE with proper poster verification by the line department then the new seats shall be added in the process of first round counselling or in the successive round of counselling as applicable. Further notification regarding availability of such seats may not be possible to be issued prior to counselling. For details please visit our website: www.tbjee.nic.in
